FY 2022 Moving To Work (MTW) Supplement to PHA Annual PHA Plan Public Notice

The Houston Housing Authority (HHA) is requesting public review and comment on HHA's Fiscal Year 2022 Moving to Work (MTW) Supplement of the Annual PHA Plan. The MTW Supplement also includes a proposed Agency-Specific Waiver and Safe Harbor Waiver. The public comment period will extend from February 28, 2022 through April 14, 2022.
