BACKGROUND:

HHA acquired the current site of HHA's administrative office located in Houston, Texas at 2640 Fountainview ("2640") and 2636 Fountain View ("2640" and collectively with 2636, the "Property"); and upon acquisition, HHA ground leased the Property to the Fountainview Public Facility Corporation in accordance with the ground lease from HHA, the PFC intends to continue operating and/or develop the Property.

Request for Proposal (RFP) #21-51 was issued on November 9, 2021, to solicit proposals for the management of the properties located at 2640 & 2636 Fountain View. The RFP was made available to interested professionals via an advertisement in the Houston Chronicle and on the HHA website. The RFP submittal due date was December 17, 2021, and HHA received one (1) response.

EVALUATION PROCESS:

All submittals were reviewed, evaluated, and ranked by a panel from the Real Estate Investment and Development Department, Public Housing Operations, Accounting, and Choice Voucher Program. Based on the following published evaluation criteria:
